All Vendors must be 13-19-years-old.

All Vendors must be **set up** and be ready to sell their products **by _____ AM/PM.**

All Vendors must have a payment source set up and have their own change for dealing with cash.

All Vendors must bring their own table, chairs, and lighting to just to light up your table such as a lamp.

All Vendors must create **their own** arts and crafts to sell.

All Arts and Crafts should be fairly priced, as this is a teen event.

All Vendors must place a card or tag on the items they are selling or in the bag in case purchaser needs to contact you.

All Vendors must not have more than 2 people per booth at any certain time (For example, vendor + PARENT or Vendor + 1 teen), and must be watching your booth during the entire event.

All vendor booths must be clean, organized, not cluttered throughout the event.

All Vendors must display professional behavior throughout the event.

All Vendors must take down their booths and be **loaded out no later than _____pm.**

All Vendors must clean up their area, including taking their trash to a trash can or dumpster.

No nude, alcohol or drug related crafts will be accepted. This is an age-appropriate event.

Teens on a Mission is not responsible for theft or item lost due to negligence of leaving your booth unattended for a period of time. Please be responsible for your personal items, as well.
